

Our meetings

ECUO General Assembly took place in Kyiv



Representatives of ECUO member-states from 15 countries of Eastern Europe and Central Asia gathered together on the eve of the Valentine's Day. During 3 days we discussed our achievements, held a voting of the President of the Union, analyzed difficulties and planned further steps towards ECUO goals achievement.

This meeting allowed all participants to share the situation in the country re access to treatment, main successes and challenges. Besides, our members could

share experience of their countries on taking commitments for securing ARV treatment at state budget cost.

One of the main results of this meeting is establishment of the Regional Advocacy Strategy (RAS) as a framework document that would regulate the main activity of our organizations in the countries re advocacy for scaling up access to ARV-treatment. The meeting allowed us to discuss and

approve advocacy country plans for Armenia, Azerbaijan, Belarus, Georgia, Moldova and Russia for 2013 (plans review on ECUO website is coming soon). We also finalized plan for support of advocacy events at regional level.

One entire day was dedicated to the information exchange and identification of the advocacy best regional practices/lessons learned among ECUO members from 7 EC grant targeted countries:



Selected Highlights

medicines in Ukraine are procured at state budget cost. They also shared on-hand experience of PLWH engagement and monitoring of the several stages of public procurement process. As a result of this monitoring they managed to prevent procurement of overpriced ARV medicines and revealed corruption schemes in MoH worth to approximately 1,5 million USD in 2012.

Representatives of PLWH organization from Georgia shared their experience in building coalition of organizations and networks working in HIV/AIDS field and harm reduction for more effective dialogue with state authorities. In 2012, they united efforts of 5 PLWH organizations to run joint public campaigns; they also signed a memorandum for joint events aimed at initiation of establishment of the transition plan for transferring patients receiving ART from Global Fund supported to State funded programs.

Representatives of Moldova PLWH League presented their experience of working in key HIV/AIDS committees at national level re securing ARV-treatment at state budget cost, as well as their participation in legal drafting of the new bill on state procurement in the context of TRIPS+ (recently signed by Moldova Government). Also, PLWH Moldova League initiated a study related to the analysis of national regulatory framework of procurement and registration of medicines, and access to generic ARV drugs.

Representatives of PLWH Armenia presented their advocacy experience re initiation of several legislative reforms that would simplify ARV drugs public procurement process after the Global Fund's withdrawal from the country.

Every country has its own specific needs. However, the financial & technical needs and the problems of co-operation with public authorities are common to all of them. Future advocacy plans were defined in line with these needs in lieu with the newly-adopted ECUO advocacy strategy - by 2020 in EE&CA countries to ensure 100% of funding for ARV treatment for all PLWH who need it and its efficient & effective application by the state budget - which for us – for people living with HIV, is an element of the right to life and health.

During the General Assembly Vladimir Zhovtyak was reelected as the President of ECUO.

The Regional Meeting "Scaling up ARV treatment in EECA region" held in Kyiv on 5 March. This meeting was attended by regional public organizations working in HIV field in Eastern Europe and Central Asia, representatives of state authorities of these countries, European Union, representatives of WHO, UNAIDS, UNDP and the Global Fund.



Discussion of the regional advocacy strategy of the East Europe and Central Asia Union of PLWH (ECUO) as well as implementation of the work plan for 2013-2014 was high on the agenda. By ECUO initiative, the decision was made to establish the Regional Advisory Group to provide technical and expert assistance in implementation of this strategy.
