Background

East Europe & Central Asia Union of PLWH (ECUO) has been awarded with EU grant to strengthen the impact of PLWH community through effective partnerships and advocacy efforts, and improve access to timely, comprehensive, quality treatment, care and support for children and adults living with HIV in Eastern Europe (EE) region. This action has a regional approach focusing on source countries (Moldova, Belarus, Armenia, Azerbaijan, Georgia), and is managed out of ECUO secretariat office in Kiev. One of the major objectives of this action is to strengthen and sustain organizational and technical capacity of the PLWH networks at national as well as regional (Kiev-based secretariat) level. Within the framework of this objective ECUO plans the development of measures to improve the sustainability of the ECUO members through elaboration and implementation of the country-specific as well as regional fundraising plan(s).

Purpose of the position

Applicant will be accountable for the development and launch of these plans.

Organizational Position

The Fundraising Expert receives technical guidance and reports to the ECUO Executive Director and Project Manager.

Duties and Responsibilities

- Development of the ECUO regional and country-specific fundraising plan(s) and associated work plan(s) in targeted National PLWH networks (Armenia, Azerbaijan, Georgia, Belarus and Moldova) - six documents in total - within the framework of ECUO strategic plan (2011 - 2015) and advocacy strategy (2012 - 2020) objectives/intermediate results (see attached), including:
 - Segregation of ECUO regional and country (where applicable) strategic development plans into smaller chunk sized bits to seek funding for each part from different sources;
 - Development of a more diversified range of donors by undertaking "donor mapping" exercise.
 - Investigating funding from non-traditional sources, such as embassies, local businessmen, faith-based organizations, through internet via networking and establishing credibility, etc.
- Serve as a regional resource person for country' financial sustainability plans development process. In doing so, applicant will closely collaborate, train and provide technical guidance to the Secretariat based fundraising specialist.
- Research and prioritize funding options at country level, including grants, past contributors, new donors, corporate contributors and foundations.
- Ensure that regional and country level fundraising activities are coordinated with ongoing process advocacy strategy development and planned activities.
- Undertake lessons learned review of successful and unsuccessful fundraising experiences and share observations/findings with ECUO leadership and partners.

• Introduce a level of professionalism that will have a positive impact on a specific initiative as well as ECUO as a whole.
